 - 聯交所,證監會及任何其他法定監管機關或政 府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構,例如彼等的銀行、律師、會計師或股 票經紀等。

4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需 的用途保留證券申請人及持有人的個人資料。無需 保留的個人資料將會根據條例銷毀或處理。

5. 查閲和更正個人資料
